Preface

Cyber security has become a key issue in virtually all domains of public sector ICT. High profile incidents have put the topic also high on the political agenda. The view of cyber security over time has changed; from an add-on to existing systems to an integral part of system design, implementation, operation and management. The General Data Protection Regulation (GDPR) heightened this even more, as it demands that data processor and data controller "shall implement appropriate technical and organisational measures to ensure a level of security appropriate to the risk" (GDPR, Art 32). In spite of the restrictions that Member States may define for certain public sector entities under Art 23 (defence, public security etc.), the effect of the GDPR also on the public sector is pervasive. This under the threat of severe penalties if breaches occur.

Cyber security however is not only a technical endeavour – which is challenging enough in itself – but also understood as an administrative and organizational challenge, which ensures that technological solutions are leveraged to the best of their abilities and in a sustainable way. This ultimately makes cyber security a cross-platform and multi-disciplinary approach, which spans the entire domain of eGovernment and eDemocracy solutions. Cyber security has become a true top management topic.

Beyond this focal topic, the conference continues to address the whole breadth of ICT in the public sector and democratic decision making, with a particular focus on the specificities of the Danube Region. This year's volume therefore again attempts to contribute to the exchange of academic knowledge and practical experience in this domain among the countries of the region. We are encouraged in this endeavour by the sizable number of paper contributions from public sector practitioners.

The editors of the proceedings volume are most grateful for the support of the Baden-Württemberg Stiftung, the Konrad Adenauer Foundation and the Austrian Cultural Forum.

The editors decided to dedicate this volume to Prof. Robert Müller-Török for his 50th anniversary. Robert is professor at the University of Public Administration and Finance at Ludwigsburg. He was instrumental in the relaunch of the conference series in 2014 and has substantially enabled and contributed to the conference. Beyond that Robert – who fluently speaks Hungarian – fostered sustainable research and teaching cooperation in the Danube Region in the field of eGovernment and eDemocracy.
